

- The Company has only one reportable business segment i.e Iron & Steel and allied products. Accordingly, separate segment information as per Ind AS 108 are not applicable.
- The Government of India introduced Good and Service tax (GST) w.e.f. 1st July, 2017. Sales are recorded net of GST whereas earlier sales were recorded gross of Excise Duty which formed part of expenses. Hence Revenue from Operations for the year ended 31st March, 2019 is not strictly comparable with corresponding year.
- 4. Pursuant to approval of the shareholders vide resolution dated 26th September, 2018 the Equity Shares of face value ₹10/were sub-divided into 5 Equity Shares of ₹ 2/- each w.e.f. 5th November, 2018. Accordingly EPS for all the reported periods has been calculated after considerating the said sub-division of shares.
- 5. The figures of the last quarter are the balancing figures between the audited figures in respect of the full financial year and the published year to date figures upto the third quarter of the respective financial year.
- 6. Figures of the previous quarter/year have been re arranged, re-grouped and recasted to conform to current period classification, wherever necessary.
